All children wishing to participate must be accompanied by an adult and must fill out the sign up form and sign the General Release form. All entry fees will be collected at the time of sign-up.

Entries will be taken on a first come first serve basis with 12 riders competing nightly on Thursday, Friday and Saturday.

OFFICIAL RULES

- 1) Only children aged 4-7 are eligible to participate. Proof of age must be provided at the time of sign-up.
- 2) The maximum weight limit for eligibility is 55 pounds, fully clothed. Weight will be determined by weigh-in at the time of sign-up. Due to the safety concerns of the stock, there will be no exceptions to this rule.
- 3) All contestants will be provided with a helmet and safety vest at the time of the competition.
- 4) Only the contestant will be provided with a general admission ticket to the performance.
- 5) All contestants shall receive a score regardless of the length of the ride, and shall be scored by the announcer and one or more committee members.
- 6) Prizes will be awarded to the winner of the Mutton Bustin', and to the best dressed contestant each night as determined by the committee.
- 7) Only one parent will be allowed in holding area and arena per household.
